The Annotated Criminal Code

The *Practitioner's Criminal* Code not only provides the full text of the *Criminal Code*, but it also provides informative practice notes for each section. Do the following to retrieve a section of the Criminal Code from *The Practitioner's Criminal Code*:

In the Red Bar, start typing in **Practitioner's Criminal Code** and in the resulting suggested sources, click on *Practitioner's Criminal Code* to set it as a filter on the Red Bar:

Then simply type in the section that you want to retrieve into the Red Bar and run the search:

Noting Up a Section or Finding Point-in-Time Versions

To access a section of the *Criminal Code* in order to find point-in-time versions of the section or to note up the section, simply type into the Red Bar: **Criminal Code**, the word **"section"** and the **number of the section**. Do not try to put in a subsection number. You can also select **CA Legislation** as content type in the pre-filter dropdown option available on the right side of the red bar.

Quickly Determine Sentencing with the Sentencing Quantums

Once you have retrieved the Quantums, you will use the filters on the left of the screen to further refine the list. Note that you have many options to filter including *sentencing considerations, particular sanctions, jurisdiction* and *court*.
