The California Jury Instructions Civil and Criminal (CLAUSE;CLCJI, and CLCJIC) was taken down the week of January 25, 2004, due to the arrival of the new LexisNexis Automated Judicial Council of California Civil Jury Instructions product.

Andrews Publishing did not renew their LexisNexis contract. The Andrews individuals files have been removed from LexisNexis.

The Central Maine Morning Sentinel, The Kennebec Journal, and Regional Newsline have been removed from the LexisNexis services.

Due to contractual issues, our licence with Institutional Investor will not be renewed.

The Harrison Company, acquired by West Group, has terminated its licence with LexisNexis. As a result, the following treatises have been taken down: Social Security Disability Claims, Strategy and Tactics (SSDIS); Social Security Disability Practice and Procedure (SOCSEC); Preparation of Medical Cases for Settlement and Trial (MEDSET); Wilkes, Federal Postconviction Remedies and Relief (FDPOST); Wilkes, State Postconviction Remedies and Relief (STPOST); and Combined Wilkes, Federal and State Postconviction Remedies and Relief (WILKES).
