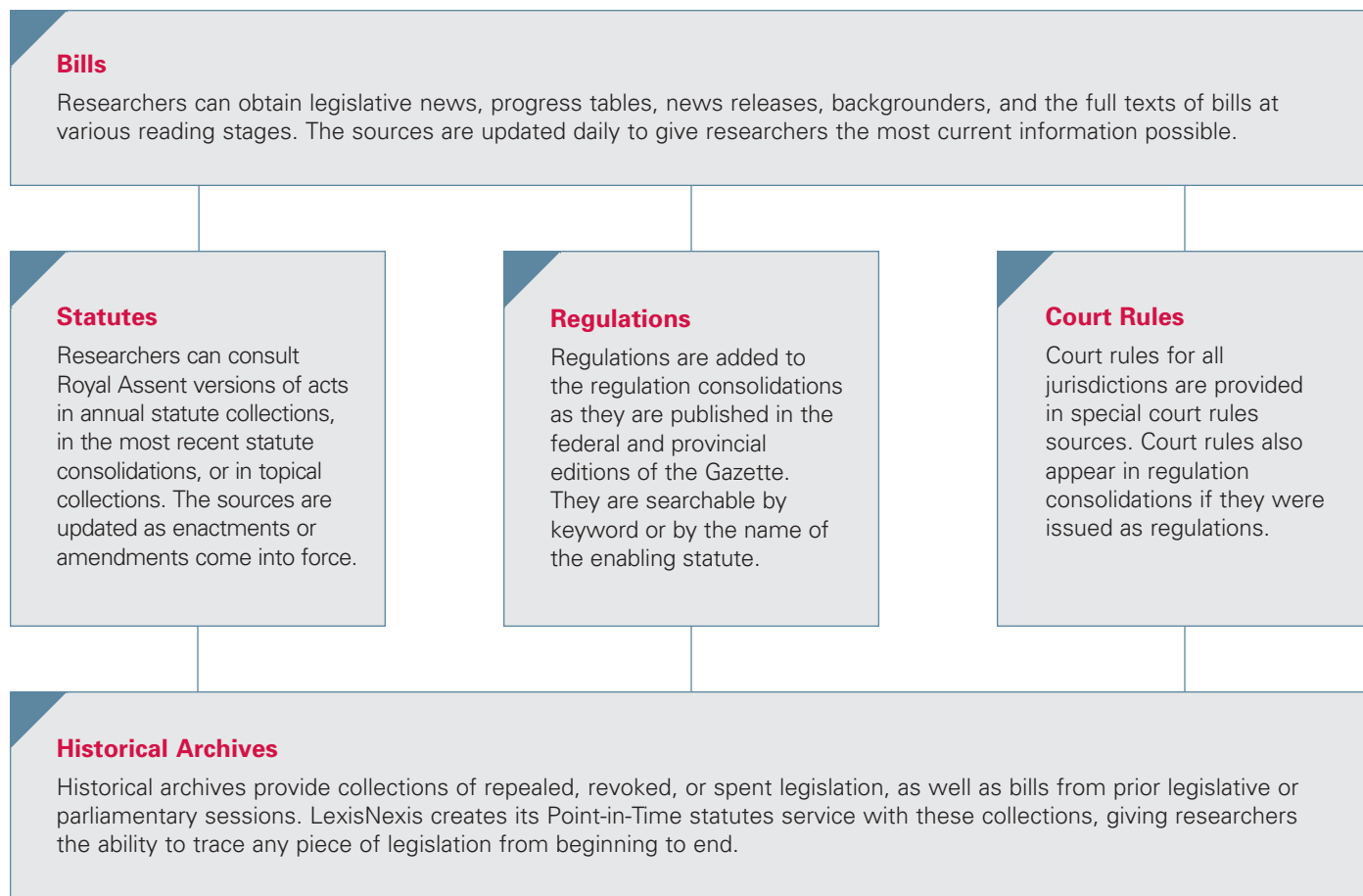
- **Entire-Act-Versions and Section-Versions** — Get an act or regulation as a single document, or search, view, print, and save by individual section — your choice for most jurisdictions.
- **Flexible Search Options** — Type terms in our easy-to-use search forms, or use our alphabetical lists of titles of acts, regulations, and court rules — it's up to you.

For our **Canada** (English and French), **Alberta**, **B.C.**, and **Ontario** collections, our legal editors update legislation daily to keep the Quicklaw collections current. Researchers can follow the complete legislative process, from the introduction of bills to the archiving of spent or repealed legislation. Additional specialized legislative research services and tools for these jurisdictions include:

- **Point-in-Time Statute Searching** — If it's not the current version of a legislative provision you require, retrieve the earlier version you need.

- **Exact Currency Information** — “Current to” dates are *Gazette* issue dates. All changes published in the *Gazette* up to that issue are incorporated in the Quicklaw consolidation.
- **Editor's Tables** — These unique tables show amendments, additions, and repeals with their effective dates, plus authorities for those dates.
- **Archives of Repealed or Revoked Acts and Regulations** — Up to 10 years of archives are available for some jurisdictions.
- **Historical References** — Quicklaw provides legislative history including amendments.
- **Topical Legislative Collections** — Access focused collections in 12 key areas of practice (available for Canada, British Columbia, and Ontario).

For Canada, Alberta, British Columbia, and Ontario, researchers can trace the following process:



Point-in-Time Statute Searching

The Quicklaw Point-in-Time search feature lets you find out what the law was at a particular time. Retrieve legislative provisions in effect on a specified date, or request all versions of the section available in the Point-in-Time archive. Make no selection at all, and receive the current version. With Point-in-Time legislative searching, you get the precise results you need in your research.

The time-saving Point-in-Time feature is available in several Quicklaw legislative collections — including statutes for Canada (English and French), Alberta, British Columbia, and Ontario, plus the *Income Tax Act and Application Rules* and eight key criminal law statutes. The Point-in-Time collection includes the following:
