Highlight and annotate vital text. When you select a passage, an options box opens that allows you to copy and paste your selection into a Word document along with the included citation. You can also annotate and save that passage to a folder or select a passage and search (throughout the entire database) with the selected text.

Toggle Highlight on to easily locate your search term within the document.



Enter terms to search within the document.



View highlighted search results in document by selecting all or individual keywords used.



A *Quick*CITE signal appearing next to a case name indicates whether the decision has received positive, negative, cautionary, or neutral treatment in subsequent judgments.



Find relevant cases faster. This feature lets you see the best clusters and the patterns of your search words at a glance. You can click on the bars to view the parts of the document where your search terms are mentioned.
